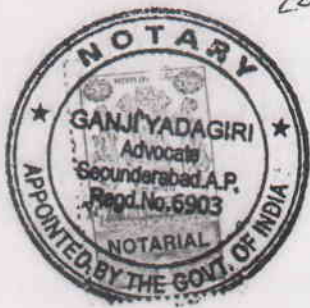
4. I state that amongst the above mentioned members, no one is related to each other. All the members are from different families, background and occupations. I state that I am not related to any of them.
